CENTRAL STATSTICAL AGENCY PRODUCER PRICE INDICES FOR MANUFACTURING (PPI-M)

April 2007 to June 2007

PPI – Total Manufacturing

In the second quarter of 2007, Producer Price Index for Total Manufacturing has increased by 2.2 percent in April, followed by a 0.7 percent increase in May, and an increase of 0.8 percent in June, as shown in Table 2 and the corresponding figure (Figure 1). Compared to the previous year's same quarter, Total Producer Price Indices rose by 12.6 percent, and 10.5 percent in April and May, followed by 11.7 percent increase in June. As depicted in Table 3, this increase in producer prices of manufactured products was contributed mainly by the rise in producer prices of food products. As compared to previous year's same quarter, Producer Price Index increased by 11.6 percent in the first quarter of 2007 (Table 4).

Figure 1: Monthly Producer Price Indices for all items (compared to the previous month)





Figure 2: Monthly Producer Price Indices for all items



PPI – Food, Beverage and Tobacco

The producer price indices of food, beverage and tobacco stood at 131.9, 132.4 and 132.7 in April, May and June as depicted in Table 1. Compared to the previous month the index increased at a rate of 1.9 percent, 0.4 percent and 0.2 percent in April, May and June respectively (Table 2). As shown in Table 3 compared to the same quarter in 2006, producer price indices exhibited a hike of around 9.6 percent in April, 4.9 percent in May and 11.0 percent in June, respectively. This was mainly attributed to the rise in prices vegetable and animal oil and Dairy products. The percentage change in producer price indices revealed that there was a 8.4 percent rise in prices of food, beverage and tobacco products in this quarter compared to the previous year's same quarter as shown in Table 4.

PPI – Other than Food, Beverage and Tobacco

monthly producer price indices manufacturing products other than food, beverage and tobacco products stood at 120.5, 121.6 and 123.0 in April, May, and June, as shown in Table 1. Table 2 shows that, producer price indices increased by 2.5 percent in April, followed by a 0.9 percent decline in May, and a 1.1 percent increase in June. On the other hand, compared to previous year's same period, producer price indices exhibited a 14.8 percent, 14.9 percent and 12.1 percent rise in April, May, and June, respectively (Refer to Table 3). This rise was mainly due to the increase in prices of nonmetallic mineral products mainly cement. The percentage change in producer prices indices between the corresponding quarters also indicated that there was a 13.9 percent increase in prices of products other than food, beverage and tobacco products as shown in Table 4.
